DISABILITY HEADLINES

Product liability, medical malpractice and other tort trials concluded in U.S. Federal courts fell by nearly 80% from 1985 to 2003 according to the Department of Justice. The median or typical damage award was \$201,000 for plaintiffs who won in tort trials concluded in 2002



and 2003. Plaintiffs prevailed in 48% of the tort cases but only 30% in medical malpractice trials and 34% in product liability.

The USA ranks number 48 for **life expectancy** (77.43 years). Singapore, Hong Kong, Japan, Switzerland, Sweden, Australia and Iceland exceed 80 years. Canada is at 79.9.

According to the National Center for Health Statistics, American Society of Actuaries, the **average life expectancy** for Americans jumped during the past half century. For females life expectancy has moved from 71 to 80 and for males from 66 to 75. Many will exceed average life expectancy. Chances of a 65 year old male and female in good health reaching more advanced ages are as follows: for females to reach 88-50% and to reach 94-25%; for males to reach 85-50% and to reach 92-25%.

According to MetLife Mature Market Institute, the **least expensive cities to get nursing care** are as follows: Shreveport, LA \$96 a day; Little Rock, AR \$117; Kansas City, MO \$121; Birmingham, AL \$123; Jackson, MS \$124; Wichita, KS \$127; Dell Rapids, SD \$128; New Orleans, LA \$129; St. Louis, MO \$133; Charleston, SC \$136. The average national cost for long-term nursing care is \$181.24. New Orleans is the least expensive place to get a home health care aide. They cost an average of \$18.12 an hour.

Researchers at Purdue University have devised an unusual method for **healing spinal injuries** in dogs and enabling them to walk again, a development that raises hope the same technique might be adapted for human use. The key is polyethylene glycol (PEG), a liquid polymer similar to antifreeze. Paraplegic animals were used along with the standard treatment of steroids, surgery and physical rehabilitation. More than half the dogs in the PEG group walked within two weeks of treatment and 13 were able to walk within 8 weeks. The investigator stated PEG works by fusing cell membranes together.

Neuro-opthalmalogist investigator sees a mysterious increase in a serious condition: **optic nerve hypoplasia (ONH)**. Symptoms are visual impairment or total blindness with serious neurological conditions. The incidence is now in thousands up from fewer than 40 cases in the western world before the 1970s. Diagnosis is possible in infancy which improves the odds of treatment.

Salaried.com has calculated the **annual value of the work America's 5.4 million stay-at-home mothers do**: \$131,471. The typical work of a stay-at-home mom with two school age children under seven fulfill a variety of job descriptions including daycare center teacher, van driver, housekeeper, cook, CEO, nurse and general maintenance worker. And, it assumed a 100-hour workweek of six 15-hour days and one 10-hour day.

According to the U.S. Census Bureau, the percentages of men and women ages 21-64 with **disabilities who are employed** are as follows: men-42%; women-34%.

Outsourcing and the growth of low-paying, service positions are likely to make it **tougher for disabled workers in the U.S. to find jobs**, despite advances in technology and more favorable attitudes among employers, experts say. According to a report by Cornell University, based on Census Bureau data, the employment rate for Americans age 21 to 64 with sensory, physical, mental or self-care disabilities fell to 38.3% in 2004, from 40.8% in 2001.

According to the 2002 Census Bureau Current Population Study on average nationwide, **high school graduates** can expect to earn about \$27,280 annually. Those with **associate's degrees** can expect an average of \$31,046 while those with a **bachelor's degree** can average \$51,194. Salaries can fluctuate depending on field and training.

According to the Bureau of Labor Statistics the percent of **workers paid at or below \$5.15 an hour by age group** in 2003 are as follows:

According to the Bureau of Labor Statistics, **wages paid to hourly wage earners** in the U.S. are as follows: 21.9 million earned over \$15.00 per hour; 23.4 million earned \$10-\$14.99 per hour; 13.1 million earned \$8.00 to \$9.99, 12.1 million earned \$6.00 to \$7.99; 2.3 million earned \$5.00 to \$5.99 and 1.1 million earned less than \$5.00 per hour.

According to the Employment Policies Institute, a number of states have passed legislation for **super-minimum wages** as follows: Oregon \$7.25; Alaska \$7.15; Vermont \$7.00; Washington \$7.35; California and Rhode Island \$6.75; Connecticut \$7.10; Delaware, Minnesota, New Jersey and (continued on page 5)

Florida \$6.15; Hawaii \$6.25; Illinois \$6.50; Maine \$6.35; Massachusetts \$6.75; New York \$6.00; and Wisconsin \$5.70.

According to the Bureau of Labor Statistics, the percentage of people ages 25 and older **unemployed**, according to education level was recently as follows: 7.5% for those with no high school diploma: 4.7% for those with a high school diploma only:

diploma; 4.7% for those with a high school diploma only; and 2.4% for those with bachelor's degree or higher.

According to the Census Bureau, these **occupations are expected to gain the most employees** from now until 2012: registered nurses, post-secondary teachers, retail sales persons and customer service representatives.

According to the <u>New England Journal of Medicine</u>, studies show that patients who have **risky surgeries** – such as the removal of part or all of an organ because of cancer – fare better if they go to hospitals that perform many of these procedures every year. The mortality rates are as follows:

According to the 2004 National Consumer Study, the **top ailments** people had during that year are as follows: backache 22%; hypertension 18%; acid reflux 16%; high cholesterol 15%; overweight 13%.

Estimates from various sources indicate that more than 50 million people suffer from **pain** and it is the leading cause of

disability in America, costing employers more than 60 billion dollars in lost productive time annually. Four sources for more specific information have websites as follows: American Pain Foundation www.painfoundation.org, American Chronic Pain Association www.theacpa.org, The National Pain Foundation www.painconnection.org, American Academy of Pain Medicine www.painmed.org.

According to the Modern Language Association, many colleges and universities now accept **American Sign Language** in fulfillment of foreign language requirements. Enrollment has increased accordingly. In 1990, only 1,602 college/university students were enrolled in such classes; 11,420 in 1998, but a huge increase occurred in 2002 with 60,781 students.

A recent publication, <u>Inside Deaf Culture</u> (Harvard University Press, 208 pages, \$22.95) by Padden and Humphries, may be of interest to those seeking to better understand the role of sign language and the history of the deaf culture in this country including a discussion of schools for the deaf as segregationist.
