About two-thirds of women between ages 18 and 34 cited a high paying career their among top life priorities, compared with just 59% of young men, according to the Pew Research Center. That was a reversal from 1997, when 56% of women rated a high - paying career high on their list of priorities, less than 58% of men surveyed back then according to Pew.

The emotional toll for Americans who lose a friend or loved one in a motor vehicle crash has a steep financial counterpart-an average six million dollars per fatal accident, according to Auto Club AAA. The study, which used 2009 data, found that the average cost of an injury-only crash is \$126,000. AAA based its estimates on Federal Highway Administration data that places dollar values on 11 components: property damage, lost earnings, loss of household activities, medical costs, emergency services, travel delays, vocational rehabilitation, lost time at work, administrative costs, legal costs and pain and lost quality of life. These dollar amounts have roughly doubled since 2005.

According to Talent Acquisition Factbook 2011, **the median cost-per-hire** by industry is as follows: manufacturing: \$6,443, business services: \$5,700, technology: \$4,339, retail: \$3,009, banking/insurance: \$2,530 and healthcare: \$2,127.

According to CollegeBoard, **the average four year cost for public college tuition climbed** from \$4,586 in 2001 to \$8,244 in 2012.

Just one percent of Americans accounted for 22% of **healthcare costs** in 2009, according to the Agency for Healthcare Research and Quality. US residents spent 1.26 trillion dollars on healthcare in 2009. Five percent accounted for 50% of healthcare costs, about \$36,000 each.

A profile of **characteristics of patients in the top ten percent of healthcare spenders in 2009 were**: 60% women, 40% 65 or older, only 3% were ages 18 to 29; 80% were Caucasian. Hispanics, 16% of the 2009 population, spent less on healthcare than other groups.

**Prescription drug abuse is the nation's fastest growing drug problem**, according to the White House Office on National Drug Policy. The Centers for Disease Control and Prevention has classified the misuse of these powerful pain killers as an epidemic with 1.3 million emergency room visits in 2010, a 110% increase since 2004. Overdose deaths on opioid pain relievers

surpassed deaths from heroin and cocaine for the first time in 2008. The term Opana has been coined to describe this phenomenon.

According to Mercer, the <u>most added benefits by</u> <u>employers</u> from 2008 to 2010 were as follows: work at home policy, lactation rooms, legal counseling and paid/subsidized off site fitness. The most dropped benefits were job sharing, long term care insurance and educational assistance.

The Social Security Administration reported that **50% of US workers earned less** than \$26,364 last year but the number of people making one million dollars or more rose by more than 18% from 2009. Despite population growth, the number of Americans with jobs fell last year, with total employment of just under 150.4 million, down from 150.9 million in 2009.

According to the National Eye Institute, an estimated 4.2 million Americans are **blind or visually impaired.** That is expected to increase by 70% in the next two decades as the population ages. One in every 12 men is color blind.

According to CareerBuilders, the following are the **"scariest"** jobs: 1) bomb squad technician 2) high rise window washer 3) armed forces 4) miner 5) police officer.

Unlike Americans, French, German, British workers use up their **vacation time**. The percentage of those who say they use it all: France 89%, Great Britain and Spain 77%, Germany 75%, Russia 67% and US 57%. (*Source: Ipsos Public Affairs*)

**Both men and women are living longer** on average, but the change is smaller for women: in 1989, lifespan for men was 71.6 years compared to 76.2 in 2009, a gain of 4.6 years. For women in 1989, the life span was 78.6 years and in 2009 was 81.3 years, a gain of 2.7 years. (Source: Institute for Health Metrics and Evaluation)

The Bureau of Labor Statistics indicates that **men are getting more new jobs** than women. Major gains for men occur in retail. The percentage of women in workplaces is down to 49.4% from 49.9%.

DIM PROSPECTS FOR DISABILITY BENEFITS PROGRAM

At the current growth rate, the SSDI Trust fund, which pays for benefits, won't have enough money to meet its obligations in 2018. In September, 2011, SSDI paid nearly 8.5 million injured workers an average of \$1,070

per month; that's up nearly 20% from 7.1 million when the recession began in December 2007. There were only about 3 million recipients in September 1990.

Roughly half of all applicants eventually get accepted into the program and less than one percent ever return to work. Among new program enrollees in 2010, more than half cited <u>back pain</u> or <u>mental problems</u> as their disabling injury, compared with just 26% of such claims in 1965. Appeal hearings reverse 60% of previous benefit denials. Between 1989 and 2009, the share of working-age Americans with SSDI benefits doubled to 4.6%, while benefit payments tripled to 120 billion over the same period. Yet, the number of SSA Disability reviews to determine if longtime recipients still meet program medical standards has fallen precipitously.

In addition to monthly benefit checks, SSDI enrollees also get Medicare coverage after two years in the program, regardless of their age. Data from an MIT study estimates that each new SSDI recipient cost taxpayers an average of \$300,000 in total lifetime costs (figured on a present value basis). In fiscal 2011, the program paid out an estimated \$130 billion dollars in benefits while the trust fund took in only \$111 billion dollars.

The nation's 3.5 million commercial truck drivers are experiencing serious health issues including obesity. A recent Gallup-Healthways Well Being Index found transportation workers to have the highest obesity rate of any industry. Truckers also have higher rates of high blood pressure and smoking than the general public. Nearly a third of them have a sleep disorder that can cause drowsiness and slowed reaction times while driving. Truckers spend long hours behind the wheel trying to cover as many miles as possible during their federally restricted driving hours. It is often difficult for them to purchase healthier fare because of truck-parking restrictions, leaving many with no dining options other than truck-stop restaurants. Many get little or no exercise.

Data suggest that about 86% were overweight and 66% were obese; that compared with 65% of the general public that were overweight and nearly half who were obese. The good news is that the trucking industry is trying to reverse those trends. Wellness programs are being established. Some truck-stops are offering healthy menu options and free exercise rooms for drivers. Many are carrying bicycles with them on the road or brown-bagging it. The federal agency that regulates commercial truck drivers is considering mandatory testing of truckers who have high body mass index readings for sleep apnea, which can cause drowsiness. One recommendation is that any driver with a BMI of 35 or higher to be evaluated for sleep apnea. That is a condition in which the air flow pauses or decreases during sleep because the airway is narrowed, blocked or floppy and repeatedly interrupts sleep, leaving sufferers fatigued.

# ATTENTION ABDA ENTREPRENEURS

ABDA prides itself on being both membership driven and innovative.
